Sub: Notice of Default against COMMERCIAL VEHICLE facility availed vide loan account number LVTNE00040887087.

We wish to state that you had approached The ICICI Bank Ltd. ["The Bank"] for availing a loan/ credit facility. Pursuant to our consideration of your application, **COMMERCIAL VEHICLE** loan/ credit facility was sanctioned to you. Upon execution of Facility Agreement between you and The Bank ("Agreement"), the Bank had disbursed the sanctioned loan/facility to you on the terms and conditions more particularly stated therein.

As per the said Agreement, you had inter alia agreed to abide by the terms and conditions governing the said Agreement and had agreed to make timely repayment of monthly installments/ fees / other charges as per the repayment schedule of the said Agreement or as per statement of account raised upon you by The Bank.

It is clarified that if the Overdue Amounts remains unpaid for more than 90 days from the date of first default, the loan/facility sanctioned and disbursed to you under the Agreement shall stand recalled without any further notice to you. Further, we would also like to inform you that incase of failure to make the payment of outstanding dues before 01/04/2020, your COMMERCIAL VEHICLE facility shall be classified as Non Performing Asset.

In the event of failure to make the repayment as above, , the Bank shall be compelled and constrained to initiate appropriate proceedings against you for the recovery of the entire dues under the Agreement, without any further notice to you, which you may please note.

In case if you have already made payments of the Overdue Amounts prior to receipt of this notice, you may kindly ignore this notice.

This notice is issued without prejudice to the rights and contentions the Bank has under the Agreement and in law.
